COMPLETION INSTRUCTIONS

1. This form must be completed in a clearly **legible handwriting** or in print in **BLACK INK**.
 - First names must be supplied in full.
 - ID number as it appears on your barcoded ID book or ID card, Copy of your ID book or Card must be attached.
 - If you do not have a fax no or e-mail address just write none.
 - Mark the force or service where you are affiliated.

2. Motivation for application by applicant should include a short CV of your achievements in combat rifle (eg started in 2000 and in 2005 South African C Team, ect) It must also include the reason for applying. It must also indicate the date the member started participating in combat rifle.

3. Applicant must sign on both places on the application form
 - Provincial representative must be authorised by the provincial management to commend on the application.
 - The comments must be detailed and include if the contents of the applicants version on his / her Shooting CV is correct or not.
 - Does the province consider the applicant to be a dedicated person within the guidelines of the SACRA policy?
 - The provincial representative must ensure that all the above criteria and stipulations have been met and all the required documentation is attached.
